



INDIVIDUAL HEALTH INSURANCE

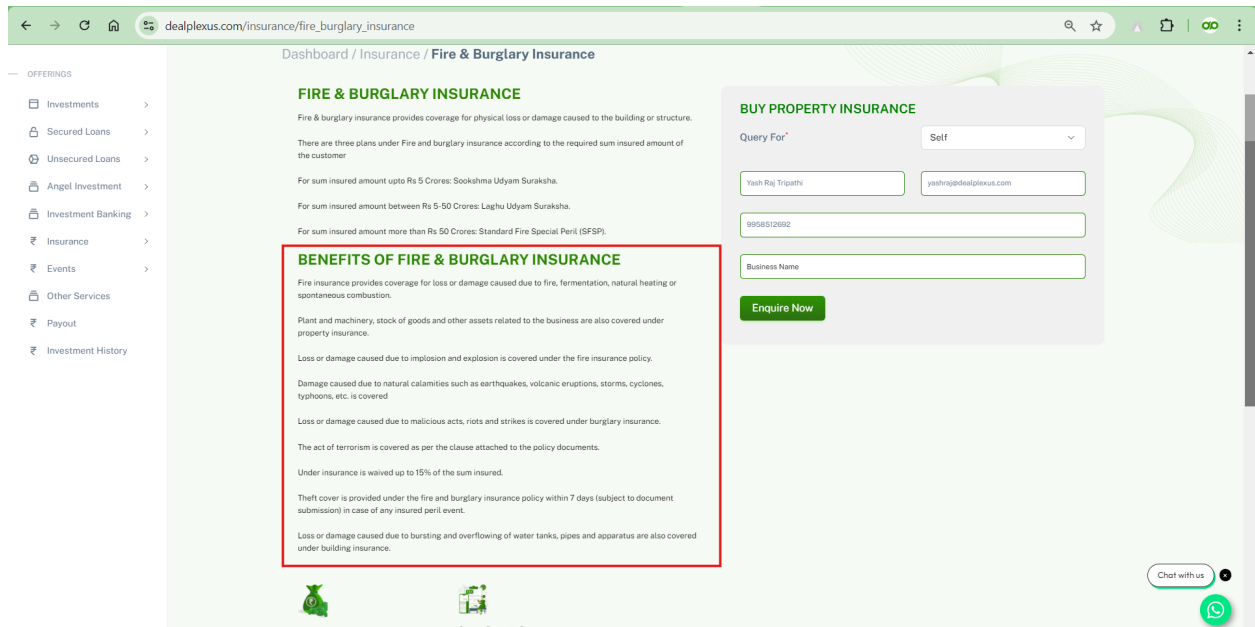

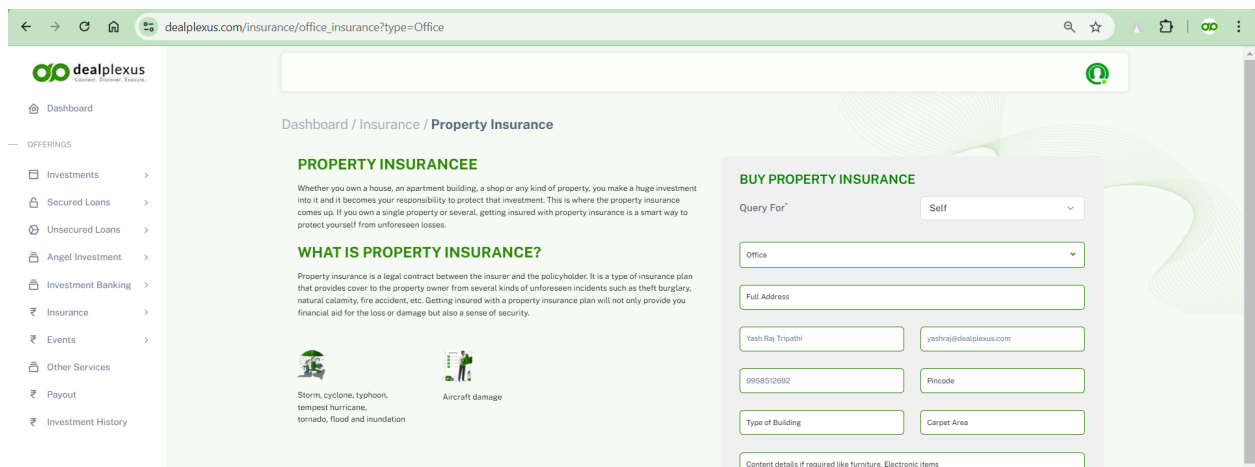

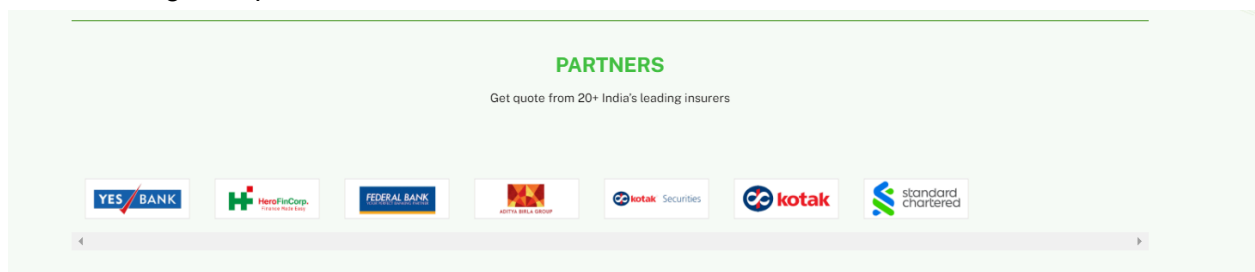
