

## CUTTING IMPORTS

### Commerce min makes list of 102 items to boost local capacity

New Delhi, November 10

THE COMMERCE MINISTRY has shared a list of as many as 102 products whose imports are high and are increasing consistently — such as coking coal, certain machinery, some chemicals, and digital cameras — to different ministries to look at ways for enhancing their domestic capacity with an aim to reduce imports, an official said.

As part of an exercise to reduce the country's import bill, the ministry has undertaken a detailed analysis of these 102 products for enhancing domestic production opportunities of those items.

According to the analysis, the import of these goods has been consistently increasing or have held high import shares across

the long, medium and short terms. The cumulative share of these items is 57.66% in total imports during the March-August 2021 period.

"These goods have domestic production opportunities," the official said adding that the commerce ministry has suggested different departments and ministries products that are showing high import growth and may be prioritised for immediate interventions to increase local production.

Out of 102, 18 products have both high share and high import growth rates. These include gold, crude palm oil, integrated circuits, personal computers, urea, stainless steel scrap, refined copper, cameras, machines for transmission of voices and images, sunflower seed oil, and phosphoric acid.

## ICRA sees competition intensifying between Indian and Chinese steel players

THE COMPETITION BETWEEN Indian and Chinese steel players could intensify at global level, amid subdued steel demand in China, according to ICRA.

In China — the largest steel-consuming country — steel-makers could brace for an extended period of weak demand as the economy goes through the process of rebalancing of an overheated property market, which was a key growth engine driving the country's steel demand for the last two decades, the ratings

agency said in its latest report. According to ICRA, in 2020-21, China emerged as the single-largest importer of steel from India. However, with the Chinese steel demand growth waning in the current fiscal, the share of steel exports to China by Indian mills has plummeted to just 8% in the first half of the ongoing fiscal from 30% in the preceding financial year.

"As demand dries up back home, a steadily rising trend in Chinese steel exports suggests that competition in the export markets between Indian and Chinese mills could intensify going forward," it said.

## ED attaches ₹6.32-cr assets of former DoT deputy DG under PMLA

THE ENFORCEMENT DIRECTORATE (ED) has attached properties worth ₹6.32 crore

of a former deputy director general (DDG) working in the ministry of communications in connection with a money laundering probe against him linked to an alleged dispropor-

tionate assets case.

The federal agency said in a statement that the action has been taken against Soumyendra Nath Banerjee and a provisional order for attachment has been

issued against him under the Prevention of Money Laundering Act (PMLA). "The attached assets are in the form of an office premise, two vacant plots of land, a three-storey commercial

building along with plant and machinery of a running company, balance kept in 47 bank accounts, two vehicles, shares held in demat accounts and two demand drafts," it said.

The total value of these properties is ₹6.32 crore.

The ED case of money laundering was filed on the basis of a CBI FIR and chargesheet against Banerjee.

# Govt seeks bids for new PM office, an 'India House' for foreign meets

THE GOVERNMENT has sought bids for a new four-storied building for the Prime Minister's Office, and the offices of the Cabinet Secretary and the National Security Council Secretary, along with a new two-storied 'India House' to be built within 24 months of being awarded. According to the plan, the 'India House' would be used to host meetings with foreign dignitaries.

The existing plots in the South Block where the buildings are proposed to be built will first be demolished, as per the plan. Work on the new residence and office of the Prime Minister,

part of the Central Vista redevelopment project, will go beyond the December 2022 completion target. The Indian Express had reported on November 4. According to the Central Public Works Department (CPWD) timeline, the PM's residence was scheduled to be completed by December 2022. But that is set to change. The plots where the PMO and the Executive Enclave are proposed to be built are currently occupied by Defence establishment buildings that are being relocated to IG Marg and Africa Avenue in New Delhi.

The CPWD, the nodal agency for the Central Vista redevelopment project, Tuesday sought pre-qualification bids for construction of the Executive Enclave that will house the

Prime Minister's Office, India House, Cabinet Secretariat and National Security Council Secretariat, at a cost of Rs 1,171 crore.

"The site is located on the south side of the existing South Block in Plot number 36/38, in high security zone. The existing structures on plot number 36/38 are to be demolished before the start of new construction. The existing boundary wall also needs to be demolished and a new boundary wall shall be constructed as per design and drawings provided by the department," the tender document said.

The proposed office buildings shall be of reinforced cement concrete frame, it noted. "Free transplantation as per the

requirement to be done and the existing services, if any, to be diverted. The structure has been designed considering the earthquake zone V," it said.

The total plinth area of the proposed building is approximately 87,915 sqm including the basement area of approximately 20,873 sqm. Under the plan, the Prime Minister's new residence is to come up on a 15-acre plot near South Block.

A spokesperson for HCP, the consultancy firm overlooking the project, had informed The Indian Express that the design for the Prime Minister's office and residence is still in its concept stage. "The broad goal is to provide modern and highly functional facilities at one location, to reduce redundancies of infrastructure, and improve city traffic management," the HCP spokesperson said.

## Covid cases cross 50 mark after 2 months

New Delhi: Delhi's daily Covid case count crossed 50 after nearly two months, on Wednesday as 54 cases were reported in the city.

The positivity rate stood at 0.09% and no deaths were reported.

The city had reported 57 cases on September 14.

At present, out of the 9,135 beds reserved for Covid patients, only 170 are occupied and 184 people are under home isolation.

Over 85,000 people were vaccinated Tuesday, and almost two thirds of these were second shots. Out of the 1.5 crore people in Delhi eligible to get vaccinated, at least 1.3 crore have got at least one shot and 77 lakh are fully vaccinated. ENS

# कोरोना के मामले फिर बढ़े, 54 नए संक्रमित

नई दिल्ली, 10 नवंबर।

दिल्ली स्वास्थ्य विभाग की ओर से जारी कोरोना रिपोर्ट के मुताबिक बुधवार को संक्रमण के 54 मामले सामने आए। हालांकि इस अवधि में किसी की मौत नहीं हुई और संक्रमण दर 0.09 फीसद रही। मंगलवार को संक्रमण के 33 नए मरीज मिले थे तो वहीं सोमवार को यह संख्या 25 थी। अबतक में संक्रमण दर बढ़कर 0.09 फीसद

दिल्ली में संक्रमण के कारण केवल चार मौतें दर्ज की गईं, जबकि सितंबर में पांच लोगों ने दम तोड़ा था। नवंबर में अभी तक कोई मौत का मामला सामने नहीं आया है। नए मामलों के साथ ही शहर में कोरोना संक्रमण के मामलों की संख्या बढ़कर 14,40,230 हो गई। इसमें से 14.14 लाख से अधिक मरीज बीमारी से उबर चुके हैं। फिलहाल मरने वालों की आंकड़ा 25,091 पर स्थिर है। दिल्ली में अभी भी 388 सक्रिय कोरोना के मामले

हैं। इनमें से 164 लोग घरों में रह कर अपना इलाज कर रहे हैं। स्वास्थ्य बुलेटिन के अनुसार, अधिकारियों ने बीते दिन करीब 58 हजार कोरोना जांच की हैं। जिनमें 45 हजार से ज्यादा आरटी-पीसीआर परीक्षण किए गए।

दिल्ली में निषिद्ध क्षेत्रों की संख्या 104 है। सरकारी आंकड़ों के मुताबिक, दिल्ली में 16 जनवरी से टीकाकरण की कवायद शुरू होने के बाद से अब तक 2.09 करोड़ से ज्यादा टीकाकरण किए जा चुके हैं। 77 लाख से ज्यादा लोगों को दोनों खुराक मिल चुकी है।
